Try to avoid words like "bank", "insurance", "university", and "education"

### PEOPLE



#### Local director / Nominee director details

Your company must have at least one local director (citizen or permanent resident). You'd need toprovide their:

- Identity Card (IC)
- Contact details (email address and phone number)

### **Other directors**

Note that if you are holding an EP from another company, you can't be a director unless you switch to anew EP associated with your business. Should you want to have more than one director, you'd need toprovide the following for each person:

- ID (IC for locals, passport for foreigners)
- Contact details (email address and phone number)
- For foreigners: proof of residential address (bank statements, IRS letters, or utility bills)

#### **Shareholder details**

Make sure to provide the following details:

#### For individual shareholders:

- ID (IC for locals, passport for foreigners)
- Contact details (email address and phone number)
- For foreigners: proof of residential address (bankstatements, IRS letters, or utility bills)

#### For corporate shareholders:

- Business Extract listing shareholding structure
- Authorised representative's ID and contact details

#### **Company secretary details**

By law, you need to appoint a company Secretary within six months after incorporation. Note that a soledirector and shareholder can't act as company Secretary. If you want to appoint a Secretary at the time of incorporation, you'd need to provide their:

- o IC
- Contact details (email address and phone number)

#### Share structure details

Your constitution will need to include the following:

- Number of shares
- Paid-up capital amount
